Adult Basic Education teacher to provide instruction to eligible participants at the Porter County Jail to prepare for Indiana's High School Equivalency Test.

Minimum Qualifications:

- 1. Bachelor's Degree and Teaching license, *preferred*
- 2. Bachelor's Degree (in education or related field) and two+ years teaching experience, *considered* **Principle Responsibilities and Duties:**
- 1. Plan and deliver in-person and possibly remote instruction to prepare students for Indiana's High School Equivalency test;
- 2. Monitor, assess and document student performance and progress;
- 3. Conduct timely post-testing on students to measure progress;
- 4. Provide students with appropriate feedback and encouragement:
- 5. Maintain accurate and complete records of student information, testing, attendance and gains
- 7. Conduct weekly follow-up with students and their goals;
- 8. Supervise volunteer tutors;
- 9. Attend and participate in assigned professional development and scheduled staff meetings;
- 10. Coordinate services with other programs at the facility.

Exposure to heated/air conditioned and ventilated facilities. Exposure to a building in which a variety of chemical substances are used for cleaning, instruction, and/or operation of equipment.
